SUPPLEMENTARY REGULATIONS

1. JURISDICTION: Held under the National Sporting Code of the ACU, the Standing Trials Regulations of ACU South Eastern, these Supplementary Regulations, and any final instructions that may be issued.

2. ELIGIBILITY: The competition is open to all members of constituent clubs of the ACU riding solo machines.

3. ENTRIES: Open 1st December 2018. Close: 12th January 2019 or earlier if full. No 'on the day' entries. Limited to 130 entries.

Fees: All Solos - £18.00; Cheques and postal orders made payable to: **Sidcup & District MCC Ltd.**

Send **one or two** 9"x 5" (or bigger – with the correct stamp) stamped self-addressed envelopes with entry (see "General" below).

An administration fee of £5 may be charged on all refunds of entry fee.

4. CLASSES: A – Elite Expert. B – Expert. C – Intermediate. D – Over 40 Intermediate. E – Novice.
F – Over 50 Novice. G – Youth Elite. H – Youth Expert. I – Youth Intermediate. J – Youth Novice

5. AWARDS: Best solo - the Youngs Cup. Premiers for best in each class. First Class for next 10% of starters in each class. Second class for next 10% of starters in each class. First and Second Class awards subject to 6 starters in that class.

ENTRIES WILL CLOSE WHEN 130 ARE RECEIVED IRRESPECTIVE OF CLASS. DON'T DELAY ENTERING!

6. GENERAL: Results will be on the Club website a few hours after the trial finishes. If you do NOT want posted results, only send ONE s.a.e. There will be 2 laps of 18 to 20 sections, so long as we get sufficient observers. If you know of a willing volunteer (even for one lap), please let us know! **The marking for this trial will be ACU 22B – 'NON-STOP'. The rule is on pages 205 & 206 of the 2018 ACU Handbook – please read!**

Entry declaration: I the undersigned apply to enter the event described above and in consideration thereof: -

- I hereby declare that I have had the opportunity to read, and that I understand the National Sporting Code of the ACU, the ACU Standing Regulations, such Supplementary Regulations as have or may be issued for the event, and agree to be bound by them.
- I further declare that I am physically and mentally fit to take part in the event and I am competent to do so.
- I confirm that I understand the nature and type of event I am entering and its inherent risks and agree to accept the same notwithstanding those risks may involve negligence on the part of the organisers or officials.

- **Acknowledgement of the risks of motorsport:** I understand that by taking part in this event I am exposed to a risk of death, becoming permanently disabled or suffering some other serious injury and I acknowledge that even in the event that negligence on the part of the ACU, the promoter, the organising club, the venue owner, or any individual carrying out duties on their behalf were to be a contributory cause of any serious injury I may suffer, the dominant cause of any serious injury will always be my voluntary decision to take part in a high risk activity. I have read the above and acknowledge that my participation in motorsport is entirely at my own risk.
